10% Tuition Discount

How to Become a Global Learning Partner (GLP)

Anaheim University offers select organizations the opportunity to take part in its Global Learning Partner Program for the purpose of the enhancement of corporate personnel development and the attaining of the latest knowledge in global business strategies. Until December 31st, 2008, organizations may apply to become a GLP with no charge to the organization by filling out a Corporate Global Learning Partner Application. Aside from the scheduling of the orientation presentation, the organization is making no commitment whatsoever to the University.
